On 1/7/19, members of the Narcotics & Special Investigations Division – Gun Recovery Unit, responded to the address known as xxx, in NE Washington DC in order to execute a District of Columbia Superior Court Search Warrant upon.

Upon arrival, Officer Jordan (I) found the residence door to be unsecured and slightly ajar. (I) announced "Police" presence, loudly and clearly by stating "POLICE! SEARCH WARRANT!" (I) was the first officer to enter the residence and was carrying a MPD issued ballistic shield.

Once (I) cleared the door area of the apartment, (I) observed a pitbull/chow mix K-9 charging towards me. The K-9 (Gangsta) immediately kept towards my body area in an aggressive manner with its mouth open (teeth exposed) and growling. (I) deflected the K-9 (Gangsta) with my MPD issued ballistic shield which I was carrying in my left hand. The K-9 then made a second lunge towards my body and (I) again deflected it with the shield. The second assault was in the same aggressive manner as (Gangsta)'s first assault. Fearing a third assault and injury from the K-9 (Gangsta)'s teeth and claws, (I) fired (2) rounds from my MPD issued Glock 17 into the K-9 (Gangsta)'s body area. Upon firing the second shot from my service weapon, the K-9 (Gangsta) then ceased its attack.

Animal Control was immediately notified and responded to the scene. Animal Control issued first aid and transported (Gangsta) to Friendship Animal Hospital.

On 1/17/19 members of the Narcotics & Special Investigations Division responded to the address known as xxx Apartment in NE Washington DC in order to execute a District of Columbia Superior Cort Search Warrant upon said premises.

Upon arrival, members found the residence door to be unsecured and slightly ajar. Officer Jordan announced Police presence, authority and intent by stating "D.C. POLICE...SEARCH WARRANT!"

Immediately upon entering across the threshold of residence door into the living-room area (I) observed a tan colored Pit-Bull/Chow Mix K-9 charge at Officer Jordan all the while growling and aggressively barking, showing teeth. Upon observing the K-9, (I) immediately yelled "DOG...DOG!" in order to warn incoming officers of the threat.

(I) observed the K-9 leap at Officer Jordan to attack him in a vicious manner. Officer Jordan subsequently utilized the ballistic shield which he was carrying in his left hand to repel the K-9's attack by means of placing it between himself and the dog, ultimately pushing the K-9 backwards.

The K-9 jumped right back at Officer Jordan a second time, yet again attempting to bite the Officer upon the left arm. Being that (I) was standing directly behind him, Officer Jordan was unable to retreat in any form or fashion, which placed him in direct line of further attack by the K-9 itself.

Given the K-9's aggressive attack at him, (I) observed Officer Jordan fire two rounds of ammunition from his MPDC Glock pistol at the K-9, which immediately took effect causing the K-9 to cease it's attack and to retreat. Officers Jordan actions subsequently allowed the remaining members of the NSID's entry team to safely enter the apartment and successfully clear it accordingly.

GRU Unit was making entry into the apartment to serve a DC Superior Court Search Warrant. As Officer Jordan, Officer Hicks, and Sgt Smith entered the location, Ofc. Jordan was attacked by a dog inside the apartment. Ofc. Jordan pushed the dog away with the shield. The dog then attacked Ofc. Jordan again. Ofc. Jordan fired his duty weapon (2) times at the dog, to stop the attack.
