1 On Wednesday February 7, 2007 I received a text 2 message from Shane [REDACTED] at about 3:00 asking me 3 what I was doing. I told him I was going tanning. 4 He asked if I wanted to hang out and I said sure & 5 I told him I'd let him know when I was done tanning. 6 After tanning I texted him to tell him I was done & we could hang 7 out. I told him he could just come over. He came over at 8 about 4:15. We just sat on my bed in my room in the 9 basement for a while watching TV. He started to joke around 10 & throw pillows at me. I played back & joked around 11 too. He then asked me for oral sex & I said no. He insisted 12 that I give him oral sex but I wouldn't. He said he knew I 13 wanted to have sex with him then proceeded to take off 14 my pants. He asked if I wanted to be on top & I said no I don't 15 want to do this. I attempted to get away & by this time he 16 was opening a condom. As I struggled he flipped me over on my 17 stomach to the edge of the bed.
